A Resolution confirming the award by the Board of Control of a purchase contract with i2c Technologies, Ltd., at State Term Pricing, for the maintenance of security cameras and related equipment at the Jail, for a three-year term, for the period of 6/1/24 to 6/1/27, in an amount not to exceed \$81,764.50, for the Sheriff and Office of Information Technology, and declaring an emergency.

WHEREAS, this Council previously adopted Resolution No. 2018-329, which confirmed the award by the Board of Control of a purchase contract with i2c Technologies, Ltd., at State Term Pricing, for the purchase and installation of security cameras and related equipment at the Summit County Jail, in an amount not to exceed \$397,501.00; and

WHEREAS, after installing the security cameras at the Jail, i2c Technologies, Ltd. has provided all repairs and maintenance required for the security cameras; and

WHEREAS, the Sheriff wishes to continue to contract with i2c Technologies, Ltd. for the aforementioned maintenance contract which includes repairs and maintenance of all hardware and software, notifications, remote services, training, replacement parts and components, and camera cleaning; and

WHEREAS, the Board of Control, at its meeting held on April 24, 2024, awarded a purchase contract, subject to the approval of the Information Technology Board, with i2c Technologies, Ltd., at State Term Pricing, for the maintenance of security cameras and related equipment at the Jail, for a three-year term, for the period of 6/1/24 to 6/1/27, in an amount not to exceed \$81,764.50, subject to confirmation by County Council; and

WHEREAS, the Information Technology Board, at its meeting to be held on May 9, 2024, will consider the aforementioned contract with i2c Technologies, Ltd. for approval; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned purchase contract with i2c Technologies, Ltd. is necessary and in the best interest of the County of Summit;
