7 **A Resolution confirming the award by the Board of Control of a purchase contract with i2c**  
8 **Technologies, Ltd., at State Term Pricing, for the maintenance of security cameras and**  
9 **related equipment at the Jail, for a three-year term, for the period of 6/1/24 to 6/1/27, in an**  
10 **amount not to exceed \$81,764.50, for the Sheriff and Office of Information Technology, and**  
11 **declaring an emergency.**

13 WHEREAS, this Council previously adopted Resolution No. 2018-329, which confirmed  
14 the award by the Board of Control of a purchase contract with i2c Technologies, Ltd., at State  
15 Term Pricing, for the purchase and installation of security cameras and related equipment at the  
16 Summit County Jail, in an amount not to exceed \$397,501.00; and

17

18 WHEREAS, after installing the security cameras at the Jail, i2c Technologies, Ltd. has  
19 provided all repairs and maintenance required for the security cameras; and

20

21 WHEREAS, the Sheriff wishes to continue to contract with i2c Technologies, Ltd. for the  
22 aforementioned maintenance contract which includes repairs and maintenance of all hardware  
23 and software, notifications, remote services, training, replacement parts and components, and  
24 camera cleaning; and

26 WHEREAS, the Board of Control, at its meeting held on April 24, 2024, awarded a  
27 purchase contract, subject to the approval of the Information Technology Board, with i2c  
28 Technologies, Ltd., at State Term Pricing, for the maintenance of security cameras and related  
29 equipment at the Jail, for a three-year term, for the period of 6/1/24 to 6/1/27, in an amount not to  
30 exceed \$81,764.50, subject to confirmation by County Council; and

32 WHEREAS, the Information Technology Board, at its meeting to be held on May 9,  
33 2024, will consider the aforementioned contract with i2c Technologies, Ltd. for approval; and

35 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
36 that the aforementioned purchase contract with i2c Technologies, Ltd. is necessary and in the  
37 best interest of the County of Summit;

39 NOW THEREFORE, BE IT RESOLVED, by the Council of the County of Summit, State  
40 of Ohio, that:

44 The award by the Board of Control, subject to the approval of the Information  
45 Technology Board, of a purchase contract with i2c Technologies, Ltd., at State Term Pricing, for  
46 the maintenance of security cameras and related equipment at the Jail, for a three-year term, for  
47 the period of 6/1/24 to 6/1/27, in an amount not to exceed \$81,764.50, is hereby confirmed and  
48 the Executive is hereby authorized to execute said purchase contract and any necessary related  
49 documents.
