1 RESOLUTION NO. 2024-145 2 SPONSORS Ms. Darrow, Mr. Schmidt, Mr. Ford, Ms. McKenney, Council as a Whole 3 4 5 DATE April 29, 2024 COMMITTEE Committee of the Whole 6 7 A Resolution opposing Dominion Energy Ohio's proposed 30 percent rate increase and 8 requesting that the Public Utilities Commission of Ohio deny Dominion Energy Ohio's 9 request for the increase, for the Council, and declaring an emergency. 10 11 WHEREAS, several County of Summit residents currently receive natural gas service through Dominion Energy Ohio; and 12 13 14 WHEREAS, Dominion Energy Ohio has filed with the Public Utilities Commission of 15 Ohio, in Case No. 23-0894-GA-AIR, a request for a 30 percent increase for natural gas 16 distribution services it provides to consumers; and 17 18 WHEREAS, Dominion Energy Ohio has proposed a distribution rate increase for 19 consumers which would increase consumers monthly fixed Basic Service Charge for natural gas 20 distribution service from \$43.27 to \$56.31; and 21 22 WHEREAS, Dominion Energy Ohio has proposed to increase other fixed monthly 23 distribution charges to consumers by more than \$8.78 per month starting in 2025, increasing as 24 much as \$29.69 per month by 2032; and 25 26 WHEREAS, large rate increases in natural gas distribution service may negatively impact 27 the County of Summit's efforts to attract new business and jobs, depress the housing market, and 28 place an undue financial burden on residents. 29 30 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit, 31 State of Ohio, that: 32 33 **SECTION 1** 34 35 This Council opposes Dominion Energy Ohio's proposal to increase the monthly fixed 36 Basic Service Charge for natural gas distribution service to consumers by 30 percent and request 37 that the Public Utilities Commission of Ohio deny such a rate increase to consumers. 38 39 **SECTION 2** 40 41 This Council opposes Dominion Energy Ohio's proposal to increase other fixed monthly 42 distribution chargers to consumers to more than \$8.78 per month starting in 2025 and request 43 that the Public Utilities Commission of Ohio deny such a rate increase to consumers. 44 45 **SECTION 3** 46 47 The Clerk of Council is hereby authorized and directed to forward a certified copy of this 48 resolution to the Public Utilities Commission of Ohio, Attn: Docketing Division (Case No. 23-49 0894-GA-AIR), 180 E.
