(c) The Tax Levy will be for a six-year period of time, beginning on the tax list and duplicate for the year 2025 (collection year 2026). The proceeds of the tax levy would be distributed to the County in 2026 through 2031, inclusive.

910 SECTION 3.

In accordance with Section 5705.03 of the Ohio Revised Code, this Council authorizes and requests the Clerk of Council to certify a copy of this Resolution to the Fiscal Officer to certify to this Council the total current tax valuation of the County and the dollar amount of revenue that would be generated by the Tax Levy in the amount of 3.25 mills expressed in dollars, rounded to the nearest dollar, for each one hundred thousand dollars of the County Fiscal Officer's appraised value.

SECTION 4.

Upon receipt of the Fiscal Officer's certification and receipt of the SSAB's approval, this Council will consider for enactment legislation to submit the question of the Tax Levy to the voters of the entire territory of the County of Summit at the November 5, 2024 general election.

SECTION 5.

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the residents of the County of Summit and for the further reason to immediately enable the Fiscal Officer to calculate the amounts requested in Section 3 and to certify the question to the Board of Elections in time for the November 5, 2024 election.

SECTION 6.

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.

SECTION 7.

It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
