

Motion: M-025-2011

SUMMARY:

A Motion of Council amending M-017-2011, replacing Cazzell Smith with Frank Comunale as the Chair of the Personnel Committee, and replacing Cazzell Smith with newly appointed Council member Tamela Lee to the committees of the Council of the County of Summit for the year 2011 of which Mr. Smith was a member. Tamela Lee will also replace Frank Comunale as Chair of Long-Term Planning.


