SUMMARY:

A Motion of Council consolidating two separate ditch petitions filed with the Summit County Council office for drainage improvements for areas in The Sanctuary of Bath subdivision and Millvale Estates subdivision, located in Bath Township.

A MOTION OF THE COUNCIL OF THE COUNTY OF SUMMIT

WHEREAS, a ditch petition was filed on January 27, 2016 pursuant to Section 6131.04 of the Ohio Revised Code requesting the County to clean, remove obstructions from, restore, reconstruct, construct and repair the storm sewer and ditch stormwater drainage system serving all or parts of Lots 69, 70, 71 and 72 within The Sanctuary of Bath subdivision, all or parts of Lots 38, 39, and 40 within the Millvale Estates subdivision, and all or parts of Lots 2, 3, 4, 5, 6, and 7 within the Millvale Addition subdivision, all being residential lots and subdivisions located in Bath Township, Summit County, Ohio; and

WHEREAS, a ditch petition was filed on April 25, 2016 pursuant to Section 6131.04 of the Ohio Revised Code requesting the County to clean, remove obstructions from, regrade, restore, reconstruct and stabilize the drainage course to improve hydraulic capacity of overland drainage system running through Sublot 36 of The Sanctuary of Bath Phase 1 and Sublots 78, 79, 81, 82 and 83 of The Santuary of Bath Phase 2 and;

WHEREAS, Section 6131.13 of the Ohio Revised Code provides County Council the authority to consolidate ditch petitions which serve common territory, or which can readily be combined into one system; and

WHEREAS, Section 6131.13 of the Ohio Revised Code requires County Council to order the County Engineer to re-estimate and make such further reports and schedules as necessary upon a consolidation of proposed improvements; and

WHEREAS, this Council finds it necessary and in the best interest of the County of Summit to consolidate the two separate ditch petitions filed with the Summit County Council office for drainage improvements for areas in The Sanctuary of Bath subdivision and Millvale Estates subdivision, located in Bath Township.

NOW, THEREFORE, UPON MOTION OF A MEMBER OF THIS COUNCIL OF THE COUNTY OF SUMMIT, THE COUNCIL HEREBY:

- 1. Consolidates the two separate ditch petitions filed with the Summit County Council office for drainage improvements for areas in The Sanctuary of Bath subdivision and Millvale Estates subdivision, located in Bath Township. A copy of the original petitions that are hereby consolidated are attached hereto as Exhibits A & B.
- 2. Orders the Summit County Engineer to re-estimate and make such further reports and schedules as are necessary based upon such consolidation.
