**SUMMARY:**

**A Motion of Council confirming the appointment of Ms. India Surgeon (replacing Anja Aniere) and the reappointments of Mr. Alan Brubaker, Ms. Diane Miller-Dawson, Mayor Mike Rick, Mr. Paul Schweikert, and Mayor Mike Zita to the Community Development Block Grant Committee.**

**MOTION OF THE COUNCIL OF THE COUNTY OF SUMMIT**

Whereas, Section 2.03(2) of the Charter of the County of Summit provides that the Executive appoints officers and members of boards, agencies, commissions and authorities required by general law to be appointed by boards of county commissioners subject to confirmation by County Council; and

Whereas, on October 27, 2021, the County Executive submitted to the Council President and Clerk of Council two letters nominating the appointment of Ms. India Surgeon and the reappointments of Mr. Alan Brubaker, Ms. Diane Miller-Dawson, Mayor Mike Rick, Mr. Paul Schweikert, and Mayor Mike Zita to the Community Development Block Grant Committee.

Whereas, upon receipt of an appointment nominating letter, Section 121.06 of the Codified Ordinances of the County of Summit requires the Council President to present a Motion of Council to the County Council for its consideration and action;


NOW, THEREFORE, IT IS MOVED AND APPROVED BY THE COUNCIL OF THE COUNTY OF SUMMIT, that:

- (3) The reappointment of Ms. Diane Miller-Dawson to the Community Development Block Grant Committee with a term beginning 1/1/22 and ending 12/31/22, to serve without compensation, is hereby confirmed.
- (4) The reappointment of Mayor Mike Rick to the Community Development Block Grant Committee with a term beginning 1/1/22 and ending 12/31/22, to serve without compensation, is hereby confirmed.
- (5) The reappointment of Mr. Paul Schweikert to the Community Development Block Grant Committee with a term beginning 1/1/22 and ending 12/31/22, to serve without compensation, is hereby confirmed.
- (6) The reappointment of Mayor Mike Zita to the Community Development Block Grant Committee with a term beginning 1/1/22 and ending 12/31/22, to serve without compensation, is hereby confirmed.


