## Let's Move Summit County Health Walk Tops 500 Walkers in 4th Year

On Saturday May 20, more than 500 walkers participated in the Let's Move Summit County 4th Annual Health Walk at the Akron Zoo. Summit County Councilwomen Paula Prentice (District 8) and Gloria Rodgers (District 3) were at the forefront of the effort, which was dedicated to the ongoing issue of Infant Mortality Awareness.

Ohio ranks among the worst states in the U.S. for infant mortality and Summit County (particularly in the African American community) ranks among the highest in the state.

**District 5 Councilman David** 

Hamilton who represents a large portion of the target area, volunteered as a host for the event, and Council Members
Tim Crawford (District 7), Jeff
Wilhite (District 4) and Liz
Walters (At-Large) came out to volunteer and support the event as well.

With a large crowd on an ideal day for walking, participants were split into 3 groups between 150-200 walkers each to maximize the infant mortality awareness message presented by Council Members Prentice and Hamilton and Summit County Public Health Specialist, Shaleeta Smith. See more on page 2

## County Council, Executive Team Tour NEOMED

On Monday, June 26, 2017, Council members, Jeff Wilhite, Gloria Rodgers and Ron Koehler along with County Executive Ilene Shapiro, Community and Economic Development Director Connie Kraus, Executive Chief of Staff, Jason Dodson and Council Office Senior Research Analyst Kent Starks visited and toured the Northeast Ohio Medical University (NEOMED) in Rootstown.

NEOMED President Dr. Jay Gershen along with Daniel Blain, Vice President for Advancement and President, NEOMED Foundation; Carolyn Lanier, Chief of Staff and Vice President for Diversity, Equity and Inclusion; Richard Lewis, Vice President for External Affairs and Secretary, NEOMED Board of Trustees; Michelle Mulhern, Executive Assistant to the President and Associate Secretary, NEOMED Board of Trustees; Maria Schimer, General Counsel; Steven Schmidt, Interim Vice President for Research and Interim Dean, College of Graduate Studies; John Wray, Vice President for Administration and Finance and Elisabeth Young, Interim Vice President for Health Affairs and Interim Dean, College of Medicine were present to meet with the Summit County group and give an them an overview and updates on the school and its 107 acre campus.

Dr. Gershen led the group on a tour of the campus including the \$85 million, 177,000 square foot Education and Wellness Center; the Bio-Med Science Academy – a year round STEM+M high school; The Village at NEOMED—the University's independently operated on-campus residential apartment community and the REDIzone, the Research, Entrepreneurship, Discovery and Innovation Zone – a public-private partnership that promotes collaborations between NEOMED, regional economic development organizations and the private sector to increase the development of biotechnology for regional economic prosperity and the improvement of health worldwide.

Following the tour, the group reconvened at the Wellness Center for lunch and a discussion on how Summit County and NEOMED can work together to optimize health resources and opportunities for students and employers in the area.

"NEOMED is a unique and outstanding academic institution that is a vital partner in our efforts to attract and retain our best and brightest minds in medicine, health and biotechnology. We appreciate the leadership of Dr. Gershen and his team there and look forward to building on their growth and success in the future," said Councilman Wilhite, vice-chair of the Council's Health and Human Services Committee.

## **Council Honors Summit Choral Society**





Prior to the Council Committee Meeting on June 12, **Summit County Councilwoman at Large, Liz Walters** presented a commendation to Summit Choral Society executive director. Karen Prasser (photo above left). Summit Choral Society began in 1990 with the Masterworks Chorale. The Children's Choir Program soon followed in 1990, providing the start of a unique pathway for choral music education and performance with a vision to develop a musical community for singers of all ages who enjoy learning, growing, creating and sharing the sounds of the expansive world of choral repertoire.

Serving the Greater Akron area for 26 years, the Children's Choir Program is a unique vocal music education program for children in grades one through twelve. In 2016, 179 children from over 100 schools in six counties participated. Singers are placed in one of four Musicianship Classes and the appropriate choir (Beginning Singing, Intermediate, Advanced or Performance Choirs) matched with their own musical experience and skill.
