Council Members Learn More About Ohio Canal Interceptor Tunnel

On Monday, August 28, Council **President John Schmidt** (District 2) and fellow Council **Members Jeff Wilhite (District** 4) and David Hamilton (District 5) took a trolley tour with the Akron Waterways Renewed program to learn more about the \$184 million Ohio Canal Interceptor Tunnel (OCIT) project. After watching a brief introductory video in Council Chambers, the members boarded the trolley at the Ohio Building for a 90 minute tour of the tunnel - a 6,240 foot structure that is 27 feet in diameter and can store more than 25 million gallons of water from **Combined Sewer Overflow** (CSO).

The Trolley tour included stops at each of the OCIT sites:

OCIT1, where the Tunnel Boring Machine (TBM), "Rosie" was assembled and began drilling at a depth of 50 feet located near Cuyahoga and Otto streets and visible from Hickory Street.

OCIT2, located near Rand and Glendale Avenues and W. Market Street where there is a 40foot diameter drop shaft and seven connecting structures. Rosie will drill at a depth of 117 feet at this location.

OCIT3, located near West Exchange St. and the Ohio and Erie Canal visible from the West Exchange Street bridge, will have a 45-foot diameter drop shaft. Rosie will drill at a depth of 166 feet there. At that point, the TBM (Rosie) will be disassembled piece by piece and removed from the site with a crane.

The tour also included stops at Cascade Village Storage Basin (CSO Rack 15), the only round basin, measuring 125-feet in diameter with a storage capacity of 1.5 million gallons and the Forge Field Storage Basin (CSO Rack 14) a 19,716 square foot basin with a storage capacity of 2 million gallons.

Approximately 25% of Akron's sewers are combined. These sewers allow sanitary sewers (what goes down the drain at your home or business) to combine with storm sewers (the sewers along streets and buildings that collect rainwater). For most of the 20th century, there would be times during rain events that combined sewer overflows (with a mix of stormwater and a small portion of sanitary sewage) discharge (flow) into our waterways, including the Cuyahoga River, the Little Cuyahoga and the Ohio & Erie Canal. Also, during these wet weather events, the Mud Run Pump Station could overflow to the Tuscarawas River.

The City's CSO "Long Term Control Plan" (LTCP), which was submitted to the federal and state Environmental Protection Agencies (EPAs), will improve the sewer system by achieving zero untreated overflows in a typical year, thereby improving water quality in our streams and rivers.

The City of Akron submitted an Integrated Plan to the EPA in August of 2015 to modify the current LTCP. The Integrated Plan is intended to provide an earlier water quality benefit, at a reduced cost with a more appropriate schedule.

The Integrated Plan proposes to decrease the amount of storage basins from 10 down to five, to increase the amount of sewer separations from five to 13 with added green infrastructure, go from two tunnels to one – all of which could potentially save the City approximately \$300 million. Additionally, the City is seeking approval to stretch the timeline from completion in 2027 to completion in 2040.

County Triangle Building Renamed for Russ Pry

On Monday, July 31, 2017, Summit County Executive Ilene Shapiro was joined by a few hundred local business owners, community members, government dignitaries and county government employees to dedicate the County office building at 1180 South Main Street in Akron as the Russell M. Pry Building.

During the ceremony, Pry was praised by the federal, state, county and local leaders for his vision in consolidating eight different County offices from three different locations into the Russell M. Pry Building, with a focus on providing quality services to members of the public. The Russell M. Pry Building opened to the public in February of last year and is expected to save the County millions of dollars over the next decade. Since its opening, the \$23 million facility has been praised as an example of efficiency in government, while at the same time receiving recognition for its creative re-use of a historic WWII-era Firestone Tire Company manufacturing facility.

Pry served as County Executive from July 2007 until his passing on July 31, 2016.
