Council Members Host Early Kindergarten Registration Event with APS

County Hires New Chief Information Officer



On Sunday, June 7th, Summit County Council Members, Tamela Lee and Frank Comunale joined EMS (Education + Motivation = Success) and Akron Public Schools (APS) to host a FREE Kindergarten Premiere Movie, "Paddington", at the Akron Civic Theater. The movie was part of a larger Early Kindergarten registration event for Akron Public Schools.

When the doors opened at 1:00 p.m., EMS Volunteers from Arlington Church of God, First Apostolic Faith, House of the Lord, Sanctuary of Praise, Mountain of the Lord and Zion Apostolic Faith were there to greet a steady flow of nearly 200 people with Kindergarten aged children and guide them to registration areas where they were registered by APS staff for the upcoming 2015-16 school year.

In addition to the EMS and APS support, families without birth records or immunizations were aided by staff from the Summit County Public Health Office who offered free "Government Use" birth certificates for registration that day and on site immunization clinics for children in need of updated shot records.

Following registration, the children and their families were able to go up to the mezzanine level of the theater at the PNC Bank "Fun Zone" where they received FREE healthy snacks; were able to make their own "Hollywood Star"; get their face painted in their favorite character and meet and take pictures with "Paddington" bear.

The main auditorium doors opened at 3:00 p.m. and the children and families were greeted from the stage by event coordinator, Kent Starks, event hosts Pastor Diana Swoope from Arlington Church of God and Pastor Samuel Hampton from First Apostolic Faith; Summit County Council Members, Frank Comunale and Tamela Lee and Akron Public Schools Superintendent David James. The feature attraction, Paddington was then shown on the "big screen" under the stars of the historic Civic Theater.

Let's Move Summit County Hosts 2nd Annual Health Walk

Summit County Council Member Paula Prentice (District 8) hosted the 2nd Annual "Let's Move Summit County!" Health Walk in downtown Akron on Saturday, April 25th. Open to the public, walkers followed a 2.7 mile route that began and ended at Canal Park, home of the Akron RubberDucks. More than 100 walkers participated in the event which included a ticket to the RubberDucks baseball game that afternoon vs. the Bowie Baysox. All registered walkers received a drawstring sportpack "Goodie Bag" courtesy of Medical Mutual, a route map card used for validation stamps along the route for a prize drawing and a wristband that allowed them FREE admission to the Akron Art Museum. The first 1,000 fans in attendance at the game will also received Webster mascot "bobbleheads" from the Akron Rubber-Ducks. Summit County employees earned 350 Vitality points for participating.

The route included stops at:

The Spaghetti Warehouse; METRO Transit Station; University of Akron at Quaker Square; Akron Art Museum; Akron-Summit County Main Library and Canal Park.

At each stop, walkers had their route cards stamped and received free samples or coupons. At the end of the route, validated cards were turned in for a chance to win prizes in a drawing that was be held during the Rubber Ducks game.

Prizes included restaurant Gift Cards for:

"Better health, nutrition and fitness is an ongoing goal for us and we'll continue to plan and participate in events that will keep people moving in Summit County," she concluded.

Comunale and the Akron Education Association, and every family went home with a Kindergarten "Goodie Bag" filled with prizes and supplies from the Summit County Department of Job and Family Services, Summit County Executive, Russell M. Pry, Summit County Council Office, Akron Summit Community Action Head Start and Summit Education Initiative, and reading books donated by Akron Children's Hospital. Metro RTA provided FREE transportation to families to and from the event.

"We had a wonderful event today. It is so important that our children get registered for school early so that they are prepared from day one to learn and succeed in school. I can't say enough about the volunteer support we received and the overall "team effort" of all our partners involved to make this such a special day for these children and their families," said Councilwoman Lee.

Leadership Akron Distinguished Leader Recognized by Council

Pariso, vice president and private wealth advisor with Ameriprise Financial Inc., was honored for his entrepreneurial creation of the Polar Bear Jump, as well as his ability to strategically grow the event to a six-figure fundraiser that benefits local non-profits. Pariso established the Polar Bear Jump in 2003 as a fundraising opportunity to support Akron Children's Hospital which would also take advantage of the Portage Lakes during the slow winter months. Now in its 12th year, the event has raised more than \$600,000 for local nonprofits such as Akron-Canton Regional Foodbank, Akron Children's Hospital, Haven of Rest, American Cancer Society, Camp Quality, Ronald McDonald House, and the March of Dimes.

Council Adopts Legislation To Establish Council Districting Commission

At its August 10th Council meeting, Summit County Council adopted a resolution by a decisive 10-1 vote for a charter amendment (**2015-331**) that would create a nonpartisan Council Districting Commission to apportion Council into legislative districts following the Federal decennial census of 2020.

If Council's plan is approved by voters in November, a Council Districting Commission would be established. This commission would be composed of five electors, not more than three of which would be members of the same political party and none of whom would be public office holders or officers of a political party.

The Charter amendment was spurred by a petition presented to Council in July from a group called "Fair Districts for Summit County." The group aimed to establish new Council representation borders in 2016, years before the next scheduled census.

In addition to combining districts to favor partisan candidates, the petitioner's plan would limit minority representation on County Council by slashing the City of Akron's representation from six districts to three.

"I'm very pleased Council sent a strong message opposing the redistricting plan in the petition," said Council President Ilene Shapiro. "Now our focus is to explain to the voters why our charter amendment is the better choice for the community as a whole."
